COUNTY OF STONY PLAIN NO. 31 ESTABLISHED

Edmonton, Thursday, September 26, 1968.

The Executive Council has had under consideration the report of the Honourable the Minister of Municipal Affairs, dated September 19, 1968, stating that:

Whereas the Minister of Municipal Affairs has received a copy of a resolution of the council of the Municipal District of Stony Plain No. 84 requesting the establishment of an area comprising the said municipal district, adjoining parts of Improvement Districts 77 and 78 and the Stony Plain School Division No. 23, as a county:

Therefore, upon the recommendation of the Honourable the Minister of Municipal Affairs, the Executive Council advises that the Lieutenant Governor in Council, pursuant to section 3 of The County Act, hereby orders as follows:

1. A county to be known as "The County of Stony Plain No. 31", consisting of the lands described in the Schedule attached hereto (hereinafter referred to as "the county"), be and is hereby established.

2. The number of councillors to be elected to the council of the county shall be seven.

3. The electoral divisions described in the Schedule hereto are the electoral divisions of the county.

4. This Order be and is hereby made effective January 1, 1969.

SCHEDULE

In range 25, that part of township 51 lying west of the North Saskatchewan River; that part of township 52 lying west of the North Saskatchewan River not within the boundaries of the City of Edmonton; in township 53, sections 4 to 9 inclusive, the north half of section 15, sections 16, 17 and 18, that part of section 19 lying south of the south shore of Big Lake, sections 20 and 21, the south-west quarter of section 22, and those parts of sections 29 and 30 lying easterly of the easterly shore of Big Lake.

In range 26, those parts of townships 50 and 51 lying north of the North Saskatchewan River; township 52; in township 53, sections 1 to 13 inclusive, those parts of sections 14 and 15 lying south of the southerly shore of Big Lake, sections 16 to 21 inclusive, that part of section 22 lying west of the west shore of Big Lake, those parts of sections 23 and 24 lying southerly of the south shore of Big Lake and that part of section 27 lying south and west of the westerly shore of Big Lake.

In range 27, that part of township 50 lying north of the North Saskatchewan River; townships 51, 52 and 53; in township 54, sections 4 to 9 inclusive.

In range 28, that part of fractional township 50 lying north of the North Saskatchewan River; fractional townships 51, 52 and 53; the south one-third of fractional township 54.

All of the above described lands lying west of the fourth meridian.

In range 1, that part of township 50 lying north of the North Saskatchewan River; townships 51 and 52; township 53 excepting there-out sections 30 and 31; in township 54, sections 1 to 5 inclusive and sections 8 to 12 inclusive.

In range 2, those parts of townships 50 and 51 lying north and east of the North Saskatchewan River; township 52; in township 53, sections 1 to 24 inclusive and sections 29 and 30.

In range 3, those parts of townships 50 and 51 lying north and west of the North Saskatchewan River; township 52; in township 53, sections 1 to 30 inclusive.

In range 4, that part of township 50 lying north of the North Saskatchewan River; townships 51 and 52; in township 53, sections 1 to 30 inclusive.

In range 5, that part of township 50 lying north of the North Saskatchewan River; townships 51 and 52; in township 53, sections 1 to 32 inclusive.

In range 6, those parts of townships 49 and 50 lying north and west of the North Saskatchewan River; townships 51 and 52; in township 53, sections 1 to 25 inclusive, those parts of sections 26 and 27 lying

south of the north shore of Isle Lake, sections 28 to 33 inclusive; the west half of township 54 lying easterly of the Pembina River.

In range 7, those parts of townships 47, 48 and 49 lying north and west of the North Saskatchewan River; townships 50 and 51; those parts of townships 52 to 54 inclusive lying easterly of the Pembina River.

In range 8, that part of township 47 lying north and west of the North Saskatchewan River; townships 48 and 49; in township 50, sections 1 to 26 inclusive, those parts of sections 27, 28, 33 and 34 lying easterly of the Pembina River, sections 35 and 36; those parts of townships 51 and 52 lying easterly of the Pembina River.

In range 9, that part of the north two-thirds of township 47 lying north and west of the North Saskatchewan River; townships 48 and 49; in township 50, sections 1 to 15 inclusive, sections 22, 23 and 24.

In range 10, in township 47, sections 13, 14, 23 to 26 inclusive, sections 35 and 36; in township 48, sections 1 and 2, 10 to 15 inclusive, 22 to 27 inclusive, 34, 35 and 36; township 49; the south one-third of township 50.

All of the above described lands lying west of the fifth meridian.

That for electoral purposes the area within the boundaries of the county shall be and it is hereby divided into seven electoral divisions described as follows:

Division No. 1

In range 25, that part of township 51 lying west of the North Saskatchewan River; that part of the south half of township 52 lying west of the North Saskatchewan River and not within the boundaries of the City of Edmonton.

In range 26, those parts of townships 50 and 51 lying north of the North Saskatchewan River; the south half of township 52.

In range 27, that part of township 50 lying north of the North Saskatchewan River; township 51; the south half of township 52.

In range 28, that part of fractional township 50 lying north of the North Saskatchewan River; fractional township 51; the south half of fractional township 52.

Division No. 2

In range 25, in township 52, sections 19 to 21 inclusive, sections 28 to 33 inclusive; in township 53, sections 4 to 9 inclusive, the north half of section 15, sections 16 to 18 inclusive, that part of section 19 lying south of the south shore of Big Lake, sections 20 and 21, the south-west quarter of section 22 and those parts of sections 29 and 30 lying easterly of the easterly shore of Big Lake.

In range 26, the north half of township 52; in township 53, sections 1 to 13 inclusive, those parts of sections 14 and 15 lying south of the southerly shore of Big Lake, sections 16 to 21 inclusive, that part of section 22 lying west of the west shore of Big Lake, those parts of sections 23 and 24 lying southerly of the south shore of Big Lake and that part of section 27 lying south and west of the westerly shore of Big Lake.

In range 27, the north half of township 52; township 53; in township 54, sections 4 to 9 inclusive.

In range 28, the north half of fractional township 52; fractional township 53; the south one-third of fractional township 54.

All of the above described lands lying west of the fourth meridian.

Division No. 3

In range 1, that part of township 50 lying north of the North Saskatchewan River; townships 51 and 52; township 53 excepting there-out sections 30 and 31; in township 54, sections 1 to 5 and sections 8 to 12 both inclusive.

In range 2, that part of township 50 lying north of the North Saskatchewan River; that part of the east two-thirds of township 51 lying north and east of the North Saskatchewan River; the east two-thirds of township 52; in township 53, sections 1 to 4 inclusive, 9 to 16 inclusive and 21 to 24 inclusive.

Division No. 4

In range 2, that part of the west one-third of township 51 lying north and east of the North Saskatchewan River; the west one-third of township 52; in township 53, sections 5 to 8 inclusive, 17 to 20 inclusive and sections 29 and 30.

In range 3, those parts of townships 50 and 51 lying north and west of the North Saskatchewan River; township 52; in township 53, sections 1 to 30 inclusive.

In range 4, township 52; in township 53, sections 1 to 30 inclusive.

Division No. 5

In range 5, township 52; in township 53, sections 1 to 32 inclusive.

In range 6, township 52; in township 53, sections 1 to 25 inclusive, those parts of sections 26 and 27 lying south of the north shore of Isle Lake, sections 28 to 33 inclusive; the west half of township 54 lying easterly of the Pembina River.

In range 7, those parts of townships 52 to 54 inclusive lying east of the Pembina River.

In range 8, that part of township 52 lying east of the Pembina River.

Division No. 6

In range 4, that part of township 50 lying north of the North Saskatchewan River; township 51.

In range 5, that part of township 50 lying north of the North Saskatchewan River, township 51.

In range 6, that part of township 50 lying north of the North Saskatchewan River, township 51.

In range 7, townships 50 and 51.

In range 8, that part of township 51 lying easterly of the Pembina River.

Division No. 7

In range 6, those parts of township 49 lying north and west of the North Saskatchewan River.

In range 7, those parts of townships 47, 48 and 49 lying north and west of the North Saskatchewan River.

In range 8, that part of township 47 lying north and west of the North Saskatchewan River; townships 48 and 49; in township 50, sections 1 to 26 inclusive, those parts of sections 27, 28, 33 and 34 easterly of the Pembina River and sections 35 and 36.

In range 9, that part of the north two-thirds of township 47 lying north and west of the North Saskatchewan River; townships 48 and 49; in township 50, sections 1 to 15 inclusive and sections 22 to 24 inclusive.

In range 10, in township 47, sections 13, 14, 23 to 26 inclusive and sections 35 and 36; in township 48, sections 1 and 2, 10 to 15 inclusive, 22 to 27 inclusive, 34 to 36 inclusive; township 49; the south one-third of township 50.

All of the above described lands lying west of the fifth meridian.
