



**CARDSTON COUNTY
IN THE PROVINCE OF ALBERTA
BYLAW NO 875.2026**

BEING a bylaw of Cardston County in the Province of Alberta to authorize the rates of taxation to be levied against assessable property within the Cardston County for the 2026 taxation year.

WHEREAS Cardston County has prepared and adopted detailed estimates of municipal revenue and expenditures as required at the Cardston County Council Meeting held on April 27, 2026;

AND WHEREAS the estimated municipal revenues from all sources other than property taxation total \$ 2,788,089.00;

AND WHEREAS the estimated municipal expenses (excluding non-cash items) set out in the annual budget for Cardston County for 2026 total \$10,312,754; and the balance of \$7,524,665 is to be raised by general municipal property taxation;

AND WHEREAS the estimated amount required to repay principal debt to be raised by general municipal taxation is \$1,789,778.00;

AND WHEREAS the estimated amount required for current year capital expenditures to be raised by general municipal taxation is \$90,450.00;

AND WHEREAS the estimated amount required for future financial plans to be raised by municipal taxation is \$ 0.00;

THEREFORE, the total amount to be raised by general municipal taxation is \$7,615,115;

AND WHEREAS the requisitions are:

AND WHEREAS the Council is authorized to classify assessed property and to establish different rates of taxation in respect of each class of property, subject to the *Municipal Government Act*, being Chapter M-26 of the Revised Statutes of Alberta, 2000;

AND WHEREAS the assessed value of all property in Cardston County shown on the assessment roll is:

NOW THEREFORE, under the authority of the *Municipal Government Act*, the Council of Cardston County, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of Cardston County:

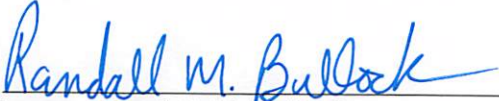

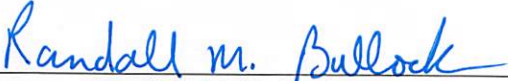
2. That the minimum amount payable per parcel as property tax for general municipal purposes shall be **\$150**
